2. Describe an interior you have encountered that is exciting, fascinating, or inspiring. This interior could include but is not limited to an exhibition, museum, gallery, retail environment, airport, civic building, digital environment, stage, or theatre production (maximum 150 words).

If you are applying for first year entry, please complete section 5 only.

If you are applying for advanced standing, please complete sections 5 to 7.

Section 5: Folio requirements – All applicants

Provide a folio of 10 pages that includes:

- Process works (exploration and experimentation)
- Reference images (may include photographic images produced by you or found images)
- Completed works

In your folio, it is essential to include work you have produced that demonstrates how you have engaged in a creative process and creative thinking. This can include work from previous studies, projects you did in school, and work you did in your personal time.

You are encouraged to include the following in your folio:

- Drawings such as plans, perspectives, diagrams, observations (digital, analogue)
- Mixed-media pieces, paintings and collages (scanned or photographic documentation of these works)
- Models and objects (photographic documentation of these works)
- Installations and exhibitions (photographic documentation of these works)
- Photographic imagery and film-based works.

Submission instructions

- Your folio containing a maximum of 10 pages (maximum size 20MB) must be uploaded as a single PDF in a screen format (1920 X 1080 pixels) and must be named as follows: (your first name)_(your surname).pdf.
