Section 4: Applicant statements

1. Outline and discuss the areas of fashion design and types of practice specialisations you would like to investigate in this program. Explain the context of fashion practice you would like to work in, relating this to your current career goals, research interests in fashion design and how this program will help you achieve these.

You may also wish to include how your work experience and previous studies has informed your research and practice interests. (maximum 300 words).

2. Provide details of academic achievements and professional experience including any work experience you are currently undertaking (maximum 150 words).

Section 5: Folio

You must provide a folio of no more than 10 pages, comprising a variety of creative projects.

Your folio should contain examples of projects from your undergraduate studies, including any major graduating projects or collections produced and any professional projects undertaken. Your folio should be a combination of images, drawings, sketches, paintings, photographs or films showing the research and design experimentation that has led to the finalised design work. It should reflect your design, problem solving and technical skills with a focus on the following:

- evidence of research and conceptual analysis
- evidence of design process (including annotations of design process: draping, pattern making and construction techniques)
- evidence of sustained written work
- finished garments or prototypes in physical or documented form
- publications, photographs, films or other forms of fashion communication
- evidence of how ideas were developed as well as finished work

Under each project provide a brief written explanation, including the purpose and background of the work.

Your folio should include work that shows how the use of documentation has informed your design and research as well as the types of design processes you work with. Please include any other complimentary projects that might be from other discipline areas that also indicate the types of design specialisations you are interested in.

Submission instructions

The maximum pages allowed is **10 pages** in a PDF format. Multiple images on a page are acceptable. You can photograph or scan your work, but please make sure that it is in focus and well presented. Include the page number, your full name and application number (if known) on each page.

Once you have compiled your folio in a PDF format, collate it together with this selection task form before uploading it to your online application.

Section 6: Selection video questions

All applicants must record and submit a brief video addressing the questions below:

- Introduce yourself.
- Describe one project in detail:
 - Include your research and inspiration behind the project.
 - Explain how you have developed your ideas for this project.
 - Explain the design process, prototype construction, finished work and communication or dissemination of your work if applicable.

Video upload requirements

- Videos must be no longer than 3 minutes and **you must present yourself on camera during the interview**. For reasons of equity, we will stop watching the video after 3 minutes so please adhere to the time limit.
- We will not be scoring or judging the quality of the video so you can record this video using your phone or other suitable devices.
- Please upload your video to an external site (e.g. Dropbox, WeTransfer, Google Drive, Weibo, Youku or Tudou). If you apply an expiry period on your video, please ensure that it is at least 6 months from the date of submission.
