Section 4: Applicant statement

Provide a short statement about why you wish to study this program, what you hope to achieve in your time at RMIT and where you think it might lead you in terms of a career and/or personal development (maximum 300 words).

Section 5: Project outline

Please outline a **new, original potential project** that you might undertake if you are offered a place in this program. It is important for this project to be a **new** piece of work that could be made within a three-month timeframe. It **should not be** a proposal previously written for an existing work.

Your project outline should be **one page** at a maximum and include:

- the concept rather than simply describing the production process;
- the themes you are addressing in your new project;
- the form the project will take (film, game, installation, etc);
- a clear context of the project through your own rough images or diagrams and/or referencing works and/or practitioners within your field.

You will not be expected to make this proposed project if you are accepted into this program. This project proposal is for you to demonstrate the practices you are interested in, and the strength of your conceptual and creative communication skills.

Submission instructions

- Once you completed the project outline in a PDF format (maximum size 5MB), collate it together with this selection task form and your folio from Section 6 (if in a PDF format) before uploading it to your online application.

Section 6: Folio

You must supply a folio comprising up to 20 pieces of your work. The folio should contain a variety of personal work in relevant fields of art, design, performance, narrative, media that demonstrates your interests and creative thinking as well as your conceptual, design, technical and communication skills. You are encouraged to show a broad range of works made in different contexts (for example within a course of study, professionally or self-directed)

Examples of work to include in your folio are drawings, paintings, graphic designs, photographs, motion graphics, digital images, models, sculpture, video, interactive media, games, websites, short writing pieces, and/or 2D and 3D animation. Include links to animated or interactive works if you have been practicing and studying in these areas.

In addition to your finished work, you may include your development work.

Submission instructions

- Once you have compiled your folio in a PDF format, collate it together with this selection task form and your project outline from Section 5 before uploading it to your online application.
- QuickTime movies or play throughs are acceptable; however, please ensure that the files are built or exported and open independently of the creator program. Movies must be compressed using .MP4 or H264 or equivalent compression.
- Apps, executables or games are acceptable however they must be provided for Mac OS or Open GL for the web.

- Your work or documentation of your works can also be hosted on online platforms such as YouTube or Vimeo.
- Provide a URL to your folio if hosted online. Please provide the username or password (if applicable). Please ensure that all your folio works are located within one URL instead of multiples.
