- 4. Extensive project management skills and understanding of contract negotiation, accreditation, audit and benchmarking processes for academic programs.
- 5. Demonstrated understanding of and commitment to administration, financial, governance and quality management systems within the University.
- 6. Demonstrated understanding and experience of fostering student experience.
- 7. Extensive experience in the interpretation, development and implementation of policy and procedure.
