The ASA provides strategic and targeted delivery of specialised learning support that is designed to maximise access and inclusion. With a 'digital first' model, we create digital learning resources that enable a truly global service. A priority for this position is digital fluency for digital literacy and the creation of digital learning objects, using systems and platforms that are fit for purpose.

Our service model provides study support online for all students across all cohorts, through online Study Support consultations and in-person across libraries in Study Support Hubs.

We require a culture capable of adapting and evolving to meet the needs and expectations of the Library and to define and develop digital pedagogical products that will add the greatest value. Change and
