Information Technology Services (ITS) provides RMIT University with Information and Communication Technology (ICT) systems and services and support to the university's staff and student for both administrative and academic programs. ITS is also responsible for the university's wide-area broadband network and unified communication/collaboration services. Our role is to support RMIT's high quality teaching, learning, research, and administrative activities.

Information Technology is of increasing importance to the research, teaching and learning life of a university, particularly a 'global University of technology and design' like RMIT. ITS has developed in conjunction with the broader University, an ICT Plan to 2020. This plan highlights five goals for ICT within RMIT. They include:

1. Best in class digital student experience – invest in new technologies which transform the student experience and underpin the digital strategy.
2. Innovative and efficient Service Integrator – Reposition the ICT function to source and manage services more efficiently and to focus on business outcomes through innovation.
3. Elegant global service experience and systems – Move to single global systems and processes which enable the global operating model.
4. Data to fuel differentiation & decisions – Ensure quality data and integrated systems are available to support data-based decision making and enable personalised and contextualised services.
5. Simple & secure technology foundations – ensure technology is simplified, free of duplication, and secure.

ITS has an essential role to play in realising these goals.

Position Summary

The Program Manager is accountable for the successful establishment and delivery of the Identity and Access Management (IDAM) Program within the Cybersecurity Portfolio. This includes the implementation of enterprise Identity Governance, Access Management, Role-Based Access Control (RBAC), and related integrations across Australian and Vietnam operations.

The Program Manager will lead program planning, procurement, stakeholder engagement, and delivery of the multi-year roadmap for the IDAM uplift. The role ensures all projects under the program are aligned to enterprise cybersecurity objectives, deliver measurable business value, and address existing identity management pain points across the University.

The incumbent will provide strong leadership across multidisciplinary teams, including internal staff, contingent resources, and partner vendors. The Program Manager will also play a key role in procurement activities, vendor selection, contract management, and delivery sequencing to ensure successful implementation and adoption of One Identity and related solutions.

Key Accountabilities

- Lead the planning, procurement, and delivery of the IDAM Program, ensuring alignment to cybersecurity uplift priorities and enterprise architecture standards.
- Develop and maintain the IDAM roadmap and delivery plan, sequencing program components such as Identity Governance (IGA), Privileged Access Management (PAM), Customer Identity (CIAM), and RBAC implementation.
- Manage vendor and partner engagements, including leading tender processes, evaluation, and selection activities in collaboration with Procurement and Legal.
- Oversee program governance, stakeholder engagement, and communication plans to ensure effective collaboration across business units, portfolios, colleges, and research entities.
- Lead the program team, ensuring clear accountability, delivery discipline, and adherence to best-practice program management methodologies.
- Manage budgets, forecasts, and financial performance of the program, ensuring expenditure aligns with delivery milestones and benefits realization targets.
- Identify, track, and mitigate risks, issues, and interdependencies across technical, operational, and business streams.
- Ensure the program delivers tangible outcomes for all defined personas and supports secure, efficient, and compliant identity lifecycle management.
- Drive continuous improvement, ensuring solutions and processes support long-term scalability, automation, and operational efficiency.
- Collaborate with the broader CISO and ITS leadership to ensure seamless transition of IDAM solutions into business-as-usual operations and service management functions.

Key Selection Criteria

Essential:

1. Extensive experience in senior project or program management roles delivering large-scale, complex technology programs, preferably within Cybersecurity or Enterprise Systems domains.
2. Proven track record of leading multi-vendor and multi-stream programs, including responsibility for procurement, vendor selection, and delivery oversight of third-party suppliers.
3. Strong leadership and stakeholder engagement skills with demonstrated ability to collaborate across diverse groups, including technical teams, business units, and executive stakeholders.
4. Experience in budget and financial management for multi-year program(s) exceeding \$10M, with a strong focus on benefit realization and cost transparency.
5. Exceptional communication and negotiation skills, with the ability to clearly articulate technical outcomes and strategic value to non-technical audiences.
6. Demonstrated ability to build, lead, and motivate multidisciplinary teams, including internal and contingent resources, to achieve program objectives.
7. Certification in Program or Project Management (e.g., MSP, PgMP, PMP, PRINCE2) and understanding of agile and hybrid delivery methodologies.

Desirable:

- Prior experience delivering or leading IDAM or One Identity solution implementations within large, multi-site organisations.
- Familiarity with enterprise Identity and Access Management concepts (IGA, PAM, CIAM, RBAC) and understanding of their role in cybersecurity strategy and compliance, with prior implementation experience considered advantageous.
- Exposure to higher education, government, or regulated enterprise environments.
