## SECTION 5: Folio submission

**In order for your selection task to be considered, you must include a folio of work**

Your folio must comprise **5 or more completed graphic pieces**, including a selection of process or developmental work for each piece. The folio should demonstrate your design, problem solving and technical skills. The folio must include:

- 2D and 3D design (“2D” can be any flat surface graphic, layout or illustration. “3D” can be packaging or digital)
- typography (typesetting or experimenting with type)
- the use of graphic design industry software in any stage of the design process
- drawing
- creative use of design elements (colour, texture, composition, etc)

Include a folio that shows a variety of work (different skills, mediums or audience) rather than a folio of similar pieces.

With each completed piece, provide a short statement describing the task and the outcome (maximum 50 words each). This should explain the concept and how you used design to solve a problem. The explanation should include a brief justification of selected design elements (colour scheme, composition, typeface, etc).
