- 3-dimensional design
- drawing and visualisation both by hand and digitally
- model making
- Computer Aided Design (CAD)
- material exploration
- colour, texture and form

Your folio should include evidence of how ideas were developed as well as finished work. Include work that shows how you document your ideas, creative thinking and any work that demonstrates your potential to follow a design process.

You can include work from secondary school, previous study and personal or work-related design experience (including sketchbooks), and the work can come from a variety of discipline areas (e.g. product design, model making, furniture, lighting, wearable design, illustration, photography).

Provide a short description for each project or image, including the context of development and the key activities undertaken (maximum 200 words per project)
