In order for your selection task to be considered, you must include a folio of work.

You must supply a folio comprising **no more than 15 pages of your work**. It should reflect your design thinking and technical skills in textiles design practice with a focus on the following:

- knowledge in textiles design and specialisations of practice
- evidence of research, critical and conceptual analysis
- documentation of design process and design ideas
- sustained written work including practice reflection, academic essays or creative writing
- finished textiles or prototypes in documented form
- publications, photographs, films or other forms of textile design communication

Submission instructions

- Upload your folio as a single PDF (maximum size 10MB).

Or

- Provide a URL to your folio if hosted online (please provide the username and password if applicable). The folio work must be contained and visible on one webpage.

Under each image provide a brief explanation, including the purpose and background of the work (maximum 50 words).
