#### Submission instructions

- Your folio must be formatted as PDF and the maximum number of pages allowed is four (maximum size 4MB).
- Once you completed this pre-selection kit form, collate it together with your folio in a single PDF before uploading it on your application portal.
- Film or sound based work: ensure that file types are common (maximum file size 8MB, maximum duration 4 minutes).
