In your storyboard, use images one to ten to develop the story which may lead to an unexpected, amusing or surprise ending in the last one or two images.

You may use original hand drawn graphic, collage or photographic means to create the images. The aim of this task is to help us evaluate your ability to direct and communicate your ideas using visual language. It is not an examination of your graphic or illustrative skills.
