Your folio should reflect skills in:

- design
- drawing
- creative use of colour
- communication and 3D/spatial thinking
- problem solving

The folio should also include a computer generated project displaying skills of digital competency

Examples of work to consider including in your folio are illustrations, technical drawings, paintings, graphic designs, photographs, models, sculpture, video, scripting, short stories, and/or 2D and 3D animation. A variety of work that shows your potential 2D and 3D skills is preferred.

The projects do not need to have a Visual Merchandising focus but display visual creativity.

Under each image provide a brief statement describing the project and the outcome (maximum 40 words).

Folio submission:
