- Arranged or styled flat-lay
- Outfit of the day suggestions
- Creative use of colour or texture
- Visual storytelling
- Fashion trends
- Design and make

You can include work from secondary school, previous study and personal or work-related design experience. The work can come from a variety of discipline areas (e.g. fashion pieces, accessories, design, wearable art, illustrations, photography) and/or digital profiles (e.g. social media accounts - Instagram, Pinterest, blogger pages).

Under each image, please provide a brief explanation describing the work, your exploration process and the outcome (maximum 50 words).

Your selection task will be assessed using the following selection criteria:

- Evidence of development and finished work
- Ability to provide context for your work
- Previous knowledge, skills and/or experience

Upload your folio as:

 A single PDF (maximum size 10MB). Please ensure to include the page number, and your full name and application number on each page.
