For example, your folio may include: drawings, paintings, graphic design, photographs, motion graphics, digital images, models, sculpture, video, interactive media, games, websites, short writing pieces, and/or 2D and 3D animation or reports.

You may also include development work as well as finished work. Please explain each work including its purpose and background. If your work is a collaboration, please detail precisely your role and the role of your collaborator/s (maximum 200 words).

#### Submission instructions:

- Upload your folio of images in a single PDF (maximum size 10MB)
- Flash animation and QuickTime movies are acceptable. Ensure that the files are built or exported to open independently of the creator program (maximum size 10MB).
