- Compile and upload your folio containing a maximum of 20 images and this pre-selection kit once completed as a single PDF.

Or

- Provide a URL to your folio if hosted online (please provide the username and password if applicable). Please ensure the folio link contains a maximum of 20 images. Please only provide a link to a site containing work for this application, rather than a generic website.

If your work is a collaboration, please precisely detail your role, and the role of the collaborator/s (maximum 200 words).
