1 Program

Each Statement of Enrolment is for one program only. If you're enrolled in multiple programs, you will have multiple statements.

2 Mode of attendance

This is how your program is delivered. However, each class might have a different mode of delivery e.g. Face-to-face.

3 Fund source

This describes how your program is funded.

4 Aggregated load

This is the total load for the classes that fall into the time period of this statement. The aggregated load is expressed as a percentage of the load you will need to maintain in order to complete this program in minimum time.

For the purposes of receiving income support payments and other concessions, an aggregated load of 75% or greater (a total EFTSL of 0.375 in a half year period) may be required.

5 Full load

The full load is measured against the minimum amount of full-time study for a program and equals 100% of EFTSL contribution. For higher education students, the standard full-time load for a year is 96 credit points. For vocational education students, the full load depends on the nominal hours for your program.

6 Course

A course is a unit of study.

7 Class

This is the specific offering of the course in which you are enrolled. Each course might have multiple class options you can enrol in.

8 Section

An administrative term – some classes have section codes to manage groups within a class.

9 Start date

This is the scheduled class start date. Different classes might have different start dates.

10 Census date

The census date is the last day that a student can finalise their enrolment and fee obligations for a class. Each class has its own census date.

11 End date

This is the scheduled class end date. Different classes might have different end dates.

12 Units

For higher education, the units are credit points.

For vocational education, the units are nominal hours per class.

13 EFTSL

For a year, one EFTSL (Equivalent Full-Time Student Load) is a measure of the study load of a student undertaking a program on a full-time basis.

If you see an asterisk (*), this means the class start date or end date falls outside of the calculation period for this statement, therefore the full EFTSL value has been calculated across more than one Statement of Enrolment.

14 EFTSL contribution

This is the portion of EFTSL that contributes to the aggregated load calculated for the time period on this statement.

15 Time period

For the First Half Calendar Year, the time period is 1 January to 30 June.

For the Second Half Calendar Year, the time period is 1 July to 31 December.
