Examples of work to include in your folio are drawings, paintings, graphic designs, photographs, motion graphics, digital images, models, sculpture, video, short writing pieces, and/or 2D and 3D Flash animation.

You should also **include development work** as well as finished work. We recommend you explain each work to help the selection officer understand the purpose and background of that work. If your work is collaboration, please detail precisely your role and the role of the collaborator/s. If your work was produced as part of a CAT/SAT note this on your work and detail what role you performed (i.e. did you devise the concept, write it, direct it, edit it, etc?). Also note whether the work submitted is a solo work or a group project.

Please note that the material you submit with this pre-selection kit can not be returned , so do not include original copies of your works.

Requirements for electronic media

- All images must be no larger than five megabytes each and should be formatted as PNG or JPEG files.
- Flash animation, QuickTime movies and play throughs are acceptable; however, please ensure the materials play on most common browsers (movies must be compressed using .MP4, H264 or equivalent compression). Files must be no larger than 5MB.
- Work can be submitted through online access via YouTube, websites, etc. Make sure all links are correct.
