The fifth RMIT Accounting for Sustainability Conference will be held in Melbourne, Australia.

Papers will not be limited to the conference theme and may address the broad area of interplay between accounting and sustainability. Potential topics of interest include but are not limited to:

- Carbon bubble/stranded assets/water accounting

As all papers will be subject to a double blind peer review, please remove references to author/s. Research proposals can be submitted for presentation but will not be reviewed.

Ideally papers should be a maximum of 7,500 words with an abstract of no more than 150 words.
